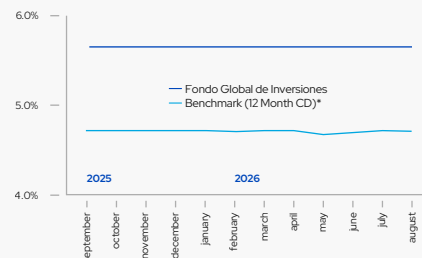

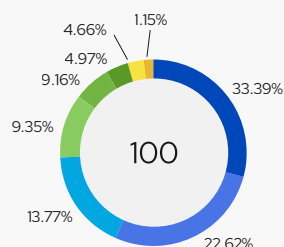

DIVIDEND YIELD VS BENCHMARK DEPOSIT



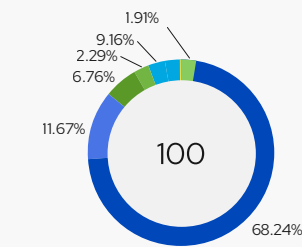

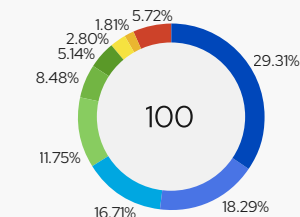

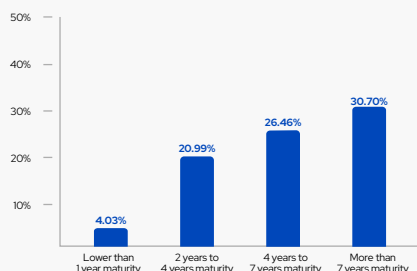
